This number of shares represents 8.81% of the outstanding Common Stock of CMGI. This percentage is based on the number of shares of CMGI Common Stock reported by CMGI in its Form 10-Q for the quarter ending October 31, 2001, filed with the Securities Securities and Exchange Commission on December 17, 2001, as being outstanding as of December 13, 2001."
